It is proposed to fill up 10 posts of Deputy Superintending Archaeological
Engineer Group 'A' (Gazetted) in the pay scale of Pay Scale of PB3 Rs.15600-
39100 + Grade Pay Rs.5400/- in the Archaeological Survey of India by transfer on
deputation basis initially for the period of three years.

Officers under the Central Government/State Government: (a) (i) holding
analogues post; or (ii) with three years' service in post in the scale of Rs.6500-
10500/- (pre-revised) or equivalent; or (iii) with three years' service in posts in the
scale of Rs.5500-9000/- (pre-revised) or equivalent; and

(b) possessing the educational qualifications and experience: (i) Degree in Civil
Engineering or in Architecture of a recognized University or equivalent; and (ii) 3
years experience in actual execution of civil works including maintenance of building
under Government or a Semi-Government Department or in a well-established
private firm.

(The departmental officers in the feeder category who are in the direct line of
promotion will not be eligible for consideration for appointment on deputation.
Similarly, deputationists shall not be eligible for consideration for appointment by
promotion. Period of deputation in another ex-cadre post held immediately pre-
ceding this appointment in the same organization/ department shall ordinarily not
exceed 3 years).

Note 1: Qualifications are relaxable at the discretion of the Union Public Service
Commission in case of candidates' otherwise well qualified.

Note 2: The qualification regarding experience relaxable at the discretion of the
Union Public Service Commission in the case of candidates belonging to the
Scheduled Castes and Scheduled Tribes, if at any stage, of selection, the
Union Public Service Commission is of the opinion that sufficient number of
candidates from these communities possessing the requisite experiences are
not likely to be available to fill up the vacancies reserved for them.

The selected officer will be entitled to the deputation allowances as admissible to Central Government employees as per rules. The applications, in duplicate, in the given proforma, along with the complete and up-dated C.R. dossier for the last 5 years of the officers who could be spared in the event of his/her selection, may be forwarded to Jt. Director (A/c), O/o Director General, Archaeological Survey of India, Janpath New Delhi -110011 within 60 days from the date of publication of this Advt. in Employment News/newspaper. Application received after the last date or otherwise found incomplete will not be considered.
