OFFICE ORDER No. 161/2008-Adm I

Whereas Section 5 (1) of the Right to Information Act, 2005 requires every public authority to designate as many officers as Central Public Information Officers (CPIO) as may be necessary to provide information to persons requesting for the information under the Act;

And whereas Section 19 (1) of the Act provides that any person who does not receive a decision within the prescribed time or is aggrieved by a decision of the CPIO, may prefer an appeal to such officer who is senior in rank to CPIO and is referred to as First Appellate Authority;


Therefore, the officers indicated in column (2) of the following table are hereby designated as CPIOs and the officers indicated in column (6) as the First Appellate Authorities in respect of the subjects indicated in column (5) of the table. This order supersedes item 1(g) and 2(e) in respect of 1(G) of office Order No.24/2008-ADM.I issued under endorsement No.F-23-9/2003-Adm.I dated 22.2.2008.
