SHORT TERM NOTICE INVITING TENDER

Tenders are hereby invited on behalf of the President of India, for execution of work under **MW (M) TO PROVIDING VITRIFIED TILES FLOORING IN FIRST FLOOR & REMAINING AREA OF GROUND FLOOR AT KAPILVASTU MUSEUM PIPRHAWHA, SIDDHARTH NAGAR**

Estimated cost of **Rs. 650488/- (RUPEES SIX LAKH FIFTY THOUSAND FOUR HUNDRED EIGHTY EIGHT ONLY)**.

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various classes of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our **website- www.asi.nic.in and e-portal eprocure.gov.in from 21.06.2017 to 30.06.2017** on payment of Rs. **500/- (non-refundable)** (Demand Draft/Banker's Cheque) in favour of Superintending Archaeologist payable at Lucknow.

2(a) The site of the work is available, or the site for the work shall be made/available in parts.

1. Tenders should always be placed in sealed covers, with the name of the work written on the envelop will be received by the Superintending Archaeologist at Circle office, Lucknow up to 15.00 hours on **03.07.2017** and will be opened by him on the same day at 15.30 hrs.
- 2.. The time allowed for supply of material will be 60 days from the 1st day after the date of written orders to commence work.
3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of PWD form No.7 and the total amount tender in the case of PWD form No.7 and total amount tendered in the case of PWD form No.8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should be attested be a witness.

5. The contractor should Quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
6. When a contractor signs a tender in an Indian language the percentage above or below and the tendered amount in case of PWD form No. 7 and the total amount tendered in the case of PWD form N0 7 and total amount tendered in the case of PWD form No. 8 and 12 should also be written in the same language. In the case of illiterate contractor, the rates or the amounts tendered should be attested by a witness.
7. Issue of tender form will be stopped two date before the date fixed for opening of tenders.

Earnest money amounting of **Rs. 16262/- (Rs. SIXTEEN THOUSAND TWO HUNDRED SIXTY TWO)** only (unless exempted) in deposit at call received of scheduled bank guaranteed by the Reserve Bank of India must accompany each tender which is to be in sealed cover super scribed tender for **MW (M) TO PROVIDING VITRIFIED TILES FLOORING IN FIRST FLOOR & REMAINING AREA OF GROUND FLOOR AT KAPILVASTU MUSEUM PIPRHAWHA, SIDDHARTH NAGAR** and addressed to Superintending Archaeologist, Archaeological Survey Of India, Lucknow Circle, Hall No. 1, 9th Floor, Kendriya Bhawan, Aliganj, Lucknow-226024.

8. The contractor whose tender is accepted (unless exempted) will be required to be furnish by way of security deposit for the due fulfillment of his contract.
 - I) In the case of works costing uptoRs. 1,00,000/- to 10% of the estimated cost of work put to tender.
 - II) In the case of works costing more than Rs.1,00,000/- and upto 2,00,000/- to 10% on the first Rs.1,00,000/- and 7 ½ % on the balance.
 - III) In the case of works costing more than Rs.2,00,000/-, 10% on the first Rs.1,00,000/-, 7 ½ on the next Rs. 1,00,000/- and 5% on the balance, subject to a maximum of Rs. 1,00,000/- only.

The security amount will be deposited by contractor in the form of FDR/CDR of any Nationalised Bank pledged to the Superintending Archaeologist, Archaeological Survey of India, Lucknow Circle, Lucknow. Earnest money deposited at the time of tender, will be treated as a part of the security deposit. The security amount will also be accepted in the shape of Government securities. Fixed deposit receipt and Guarantee bonds of schedule banks and State Bank of India will also be accepted for this purposed provided confirmatory advise is forthcoming from the Reserve Bank of India.

10. The right of acceptance of a tender will with SUPERINTENDING ARCHAEOLOGIST, ARCHAEOLOGICAL SURVEY OF INDIA, LUCKNOW CIRCLE, LUCKNOW who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.

11. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to Canvassing will be liable to rejection.
12. All rates shall be quoted on the proper form of the tender alone.
13. An item rate tender containing percentage below/above will be for payment within stipulated period this may be considered.
14. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer in charge shall be communicated to the Engineer in charge.
15. Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible. The total amount should be written both in figures and words. The case of figures, the word Rs. should be written before rupees and word (P) after the decimal figures e.g. 2.15 p and case of words the word (Rupees) should proceed and the word 'only' it should in variably upto decimal places. While quoting the area in the schedule of quantities the word only should be written closely following the amount and it should not be written closely following the amount and it should not be written in the next line.
16. The President of India does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and tenderer shall be bound to perform the same at the rates quoted.
17. Sales tax or any other or material in respect of this contracts shall be payable by the contractor and Government will not entertain any claim whatsoever in this respect.
18. The contractor must produce Income Tax clearances certificate and Permanent A/C Number (PAN) before the tender can be sold to him.
19. The Contractor shall not be permitted to tender for works in the ASI circle (responsible for award and execution of the contracts) in which his near relative is posted as an officer in any capacity between the grades of Superintending Engineer and Assistant (both inclusive). He shall also intimate the names of persons who are working with him in capacity or are subsequently employed by him and who are near relatives to any Gazetted officer in ASI or in the Ministry of Tourism and Culture by the contractor should render him liable to be removed from the approved list of contractors of this Department.

20. The contractors shall give a list of Non-Gazetted employees related to him.
21. No Engineer of Gazetted rank or other Gazetted officer employed in the Engineering of Administrative duties in an Engineering of the Government of India is aforesaid before submission of the tender of engagement in the contractor's service.
22. The tender of works shall remain open for acceptance for a period of ninety days from the date of opening of tenders. If any tender withdraws his tender before the said period or make any modifications in the terms and conditions of the tender, which are not acceptable to the department. Then the Government shall forfeit 100% of the said earnest money absolutely.
23. Contractors exempted from payment of Earnest money and Security Deposit in individual cases should attach with the tender an attested Copy of Competent authority's letter exempting them from the payment of Earnest Money and Security Deposit and should produce the original whenever called upon to do so.
24. The tender for the work shall not be witnessed by a contractor or contractors who himself/themselves has /have tendered or who may and has /have rendered for the same work. Failure to observe this condition would render of the contractors tendering as well as witnessing the tender liable to summary rejection.

OTHER TERMS AND CONDITIONS

1. The tenderer (distributors/dealer/supplier / firms) should have experience of having successfully completed similar works.
2. **The tender form dully filled in and signed on all pages and stamped by the tenderer accompanied by details of the company profile, PAN No., TIN No. , proof of work experience of similar works during the last three years in archaeological survey of India or any other government organization.**
3. The tender form must be filled in English/Hindi and all entries must be band and written in ink or neatly typed/printed. Corrections, overwriting's & erasures should be avoided.
4. Each and every page of the tender document must be signed by an authorized person.
5. The tenders must be submitted in the prescribed format only. The tenderers must quote the rates in the schedule of quantities rates and amount. The rates should be written both in words an figures without any erasures an alterations, However if errors are made, the wrong figures or words must be neatly scored under full signature of the tenderers and correct figures and words neatly rewritten, Over writing is not permitted. Applying white fluid for correcting rates and amount is also prohibited.
6. Sales Tax, VAT and any other taxes, will not be aid separately. The Tenderer must include these charges in the rates quoted, if applicable. No separate claim on this account will be entertained under any circumstances whatsoever. The tenderer shall quote his rates inclusive of cost of materials, corresponding wastages, labour, sales tax and any other taxes and duties, octroi and cost of transportation of materials to work site etc.
7. Errors in the schedule of quantities, rates and amount shall be dealt with in the following manner:
 - a. In the event of a discrepancy between the rates quoted in words and the rates in figures, lowest rate will be taken consideration.
 - b. In the event of an error occurring in the amount column as a result of wrong calculation the unit rate shall be regarded as firm and the amount shall be amended accordingly based on the quantity given.
 - c. All errors in totaling in the amount and in carrying forward, the totals shall be corrected.
8. The quantities indicated in the schedule of quantities are only approximate quantities are liable to alteration by omission, reduction or enhancement. Payment shall be made on the basis of actual quantities of work done at the accepted rates.

Should this tender be accepted, I/we hereby agree abide by and fulfil all the terms and provisions of the said conditions annexed hereto so far as applicable and or in detail thereof to forfeit and pay to the President of India or his successor in office the sum of money mentioned in the said conditions.
